## THE HISTORY OF THE STAFFORD-ABBOTT HOUSE 1018 WEST OAK STREET

The Craftsman style house located at 1018 West Oak St. was built in 1914 by Eva Woodward Long (Mrs. Joseph A. Long). Mrs. Long as a child moved to Denton County in 1877 with her parents and 6 siblings. She graduated from Baylor University in 1894. In the fall of that year, she married Joseph A. Long. J.A. Long bought Tracts 2,3 and 4 of the Mounts addition in 1896. J.A. and Eva sold Tract 2 and part of Tract 3 to Eva's widowed mother, Mrs. M.A. Woodward, in 1897. Mrs. Woodward built a house there that is now known as 1004 West Oak St.

J.A. Long died in New Mexico in 1899 at the age of 29. He and Eva had no children. A Temporary Administration was opened in Denton County, with Eva acting as the Temporary Administrator. The application for Temporary Administration recited that the corpus of the estate contained numerous parcels of real property and the proceeds from insurance policies. The application was granted. After 6 months, the administration expired. No Will was ever probated in Denton County.

Eva lived with her mother in the house at 1004 West Oak until the time of her mother's death in 1913. Eva's mother's brother, Henry Fox, also lived with them. "Uncle Banny" made his home with Eva at 1018 West Oak after that house was built. According to family members, Eva was called "Aunt Tot". Uncle Banny used the room on the west side of the 2nd floor as his sitting room. His bedroom was the room on the southwest corner. Family members also said that Uncle Banny liked to garden. Aunt Tot didn't like having mud and dirt tracked into the house, so she had a half bath tacked onto the back of the house in a small lien—to addition for Uncle Banny's use.

Talking to Eva's family members turned up some other interesting details about the house. There was a speaking tube that ran from the front door to the kitchen and the 2nd floor sleeping porch (attached to the bedroom on the east side of the house). The 2nd floor bathroom was built as a large room with the bathtub sitting out in the middle of the floor.

According to Eva's obituary, she was active in local social life. She was president of the Ariel Club and was a "large contributor" to the construction in the late 1920s of the Woman's Club building on Oakland St. in Civic Center Park. Eva was in the habit of leaving town in the summers, either staying with relatives in Los Angeles, going to Europe or Denver. One of the debts paid by her estate was the storage fee paid to a garage in Dallas where her Cadillac was stored during the last summer trip to Los Angeles. Eva was an active member of the First Baptist Church.

Eva died in Los Angeles in July of 1930. Eva left her house to one of her sisters, Leda, who moved into the house only to die about 6 months later. Eva's estate was then administered by a brother. Eva's estate was sizable for the time. The estate sold the house to Maude Hopkins right after Christmas in 1932. The last heir signed in January of 1933. Maude bought the house in her individual capacity. However, as a married woman, her husband, Robert H. "Bob" Hopkins, was legally required to co-sign the deed of trust.

Like Eva, Maude Hopkins was college educated. She and Bob married in the early 1900s. They made their home on North Elm St. where they lived until they moved to 1018 West Oak. Their home on North Elm shows up in the catalog of work of the architect Willy G. Clarkson (designer of the Women's Club Building and Lee and Peggy Capp's house on Oak St.

R.H. "Bob" Hopkins was the child of another pioneer family. His father was sheriff of Denton County at the end of the last century. Bob's brother, George Hopkins, Sr. served as the State Senator from Denton County. George, Sr. practiced law in Denton County for his entire adult life. Bob's nephew, who as a child was called "Little George", has just retired from the practice of law after over 50 years of practice in Denton. Bob served as the Judge of the 16th District Court from 1912 until 1914. His picture hangs on the wall of that Court in the Carroll Courts Building. Bob died in 1938. Maude lived in the house until the time of her death in 1957.

George Hopkins Sr. handled Maude's estate. The house was sold to the Gamma Xi Alumni of Delta Sigma Phi Fraternity in 1957. Hal Jackson, a life long Denton resident, was an alumni of the fraternity. He co-signed the note for the house in his individual capacity. The fraternity owned the house until January 1992 when it was purchased by Charles Stafford and Judith Abbott. Over the years of ownership, a procession of approximately 750 young men in turn made 1018 West Oak their home.

The house was built as a two story structure. Mrs. Long apparently paid cash for the construction of the house, as there are no construction liens recorded. According to a family member, mortgages were frowned on among the family.

The only firm date for construction came by a piece of good luck. In the process of our work on the house, we found a torn fragment of brown paper bag that had been signed in pencil. The text of that note is as follows: W.A. Croaley & Kit Berry laid this floor Nov 20, 1914". Also appearing were the following names: Edgar Davidson (Dewey), H.F. Davidson, Contractor; E.S. Litrell, Clyde Berry.

There was a one car garage north of the house that was torn down at some point in the 1960s or 1970s. By the time the tax card was prepared in 1943, a lean-to had been added to the north side of that garage. Bill Sullivant, former State Representative from Cooke County, has told us that he lived in the house as a college student. During his residency at 1018 West, he says that he installed a gym in the garage for the fraternity members to use as a work-out space.

The 3rd floor, originally attic space, was converted into 3 rooms at the time that the fraternity bought the house in 1957. Billie Clearman, Hank and Monk's brother, did the work.

We bought the house in January, 1992. Since that time, we have rebuilt much of the north wall (extensive termite damage), replaced the brick skirting, established a french drain, added piers under the middle of the living room and dining room floors. We have replumbed and rewired the house. We removed the aluminum siding that was added by the fraternity (covering the cypress siding). Much of the electrical wiring work done in the last 20 + years had been added to the house by putting conduit over the aluminum siding. We have rebuilt all the windows on the 2nd and 3rd floor, reglazing with old glass. We still have the first floor windows left to do.

The cantilevered staircase was supported by the north wall of the staircase, the wall that was used as the plumbing chase to the 2nd floor bath. The fraternity had allowed water to run into that wall for a period of not less than 2 decades. The wall had moved south about 6". The stair structure from the 2nd to the 3rd floor had racked. The stair had come loose from the 3rd floor landing. We put the wall back into an upright position and had steel plates fabricated to stabilize the stairs.

The walls of the house are plaster. 4 plaster ceilings had failed (they had come loose from the rafters where the lath or expanded wire supporting the plaster was originally attached). We were able to save all of the ceilings except for the living room ceiling.

The flooring on the first floor is quarter-sawn oak (livingroom, hall, dining room), pine in the original kitchen room and tile in the sunroom. We removed 4 layers of flooring to get down to the wood. Termites had destroyed the north 6 feet of the flooring in the dining room and about half of the floor in the original kitchen room and breakfast room. We located salvage oak to rebuilt the floor in the dining room and entry hall. We used the salvage from the original breakfast room to complete the flooring in the original kitchen. The original breakfast room (now the kitchen) currently has a painted plywood floor.

At some point the fraternity decided that they needed an additional bedroom worse than they needed a kitchen. They stripped out the kitchen. We decided to change the kitchen to the room directly under the 2nd floor bathroom. We are using the original kitchen room as a pantryroom and breakfast area. We have used salvage cabinets throughout. Nancy and Randy Boyd had saved the original cabinets and the sink from their house. They gave them to us. I bought 3 large cabinets from a salvage yard. We inherited a 7'long, 20 drawer base cabinet (salvaged by Charlie's aunt, Dorothy Stafford. She had gotten it from her church, the Northside Bapt. Church, in Ft. Worth when they remodeled in the 1950s). As money becomes available, we have been filling in around the salvaged cabinets with custom cabinets that fill out the space available.



# Mrs. Joe Long of Denton Dies in Los Angeles, Cal.

Analysis of certain items in disbursements:

(a) Under the will of Eva W. Long five persons named therein were entitled each to an undivided 1/11th interest while Leda McCormick, now deceased, and for whose estate Jack Christal is independent executor, was entitled to 6/11th interest. Under a previous order of this court, a partial distribution of funds has been made to these beneficiaries aggregating Fortyfour Thousand (\$44,000.00) Dollars. In the above disbursements appears an item to Jack Christal, executor, of Twenty-three Thousand Two Hundred Fifty (\$23,250.00) Dollars, which lacks \$750.00 being 6/11ths of the \$44,000.00 so disbursed, but under another order of the court said executor was permitted to accept a certain automobile belonging to the estate at a value of \$750.00, which added to the partial disbursement will aggregate the full amount to which Jack Christal as executor was entitled under said partial disbursement. Since the automobile was not sold by this

administrator it did not enter into the cash receipts and disbursements and this occasioned the apparent difference in the amounts received by the several legatees.

(b) The item in the disbursements of \$1675.37 as commissions to this administrator is shown to be a partial payment for the reason it was not known at that time what the aggregate commission would be but later in this report a complete statement is shown of commissions earned, crediting the estate with the above amount shown paid.
